Public Notice is hereby given that I, Chuck Broerman, El Paso County Treasurer, pursuant to section 39-10-111.5, Colorado Revised Statutes, will strike off to El Paso County the tax liens on the manufactured and mobile homes listed in this publication for which property taxes remain unpaid at the close of business on November 3rd, 2026. The county strike-off will be conducted in the El Paso County Treasurer’s Office, 1675 Garden of the Gods Road, Ste. 2100, Colorado Springs, Colorado, on Wednesday, November 4, 2026, commencing at 9:00 a.m.

This published list identifies manufactured and mobile homes classified as personal property and located in El Paso County for which property taxes remain delinquent for the indicated years. Each tax lien will include the delinquent property taxes, accrued interest, advertising costs, and other statutory fees, costs, and expenses due at the time of the strike-off.

Unless an eligible underlying landowner timely exercises the statutory right of first refusal provided by section 39-10-111.5(6)(e), C.R.S., each tax lien will be struck off to El Paso County and made a county-held lien. The Treasurer will issue a certificate of purchase to El Paso County or, when the right of first refusal is properly exercised, to the eligible underlying landowner.

The strike-off or issuance of a certificate of purchase does not immediately transfer ownership of the manufactured or mobile home. The mobile home owner retains the statutory right to redeem the tax lien in accordance with section 39-10-111.5 and other applicable provisions of Colorado law.

Language translation and interpretation services are available at the El Paso County Treasurer’s Office. A contracted interpreter will be made available in person upon request.

Por medio del presente se notifica al público que yo, Chuck Broerman, Tesorero del Condado de El Paso, de conformidad con la sección 39-10-111.5 de los Estatutos Revisados de Colorado, adjudicaré al Condado de El Paso los gravámenes fiscales sobre las viviendas prefabricadas y casas móviles incluidas en esta publicación cuyos impuestos sobre la propiedad permanezcan pendientes de pago al cierre de operaciones del 3 de noviembre de 2026. La adjudicación al Condado se llevará a cabo en la Oficina del Tesorero del Condado de El Paso, ubicada en 1675 Garden of the Gods Road, Ste. 2100, Colorado Springs, Colorado, el miércoles 4 de noviembre de 2026, a partir de las 9:00 a. m.

La lista publicada identifica las viviendas prefabricadas y casas móviles clasificadas como bienes muebles, ubicadas en el Condado de El Paso, cuyos impuestos sobre la propiedad correspondientes a los años indicados permanecen en mora. Cada gravamen fiscal incluirá los impuestos sobre la propiedad pendientes de pago, los intereses acumulados, los costos de publicación y los demás cargos, costos y gastos establecidos por ley que se adeuden al momento de la adjudicación al Condado.

A menos que un propietario elegible del terreno subyacente ejerza oportunamente el derecho legal de preferencia establecido en la sección 39-10-111.5(6) (e) de los Estatutos Revisados de Colorado, cada gravamen fiscal será adjudicado al Condado de El Paso y se convertirá en un gravamen en poder del Condado. El Tesorero emitirá un certificado de compra al Condado de El Paso o, cuando el derecho de preferencia se ejerza debidamente, al propietario elegible del terreno subyacente.

La adjudicación al Condado o la emisión de un certificado de compra no transfiere inmediatamente la titularidad de la vivienda prefabricada o casa móvil. El propietario de la vivienda prefabricada o casa móvil conserva el derecho legal de redimir el gravamen fiscal de conformidad con la sección 39-10-111.5 y las demás disposiciones aplicables de la legislación de Colorado.

Hay servicios de traducción e interpretación disponibles en la Oficina del Tesorero del Condado de El Paso. Se pondrá a disposición un intérprete contratado para brindar asistencia en persona cuando se solicite.
