WHEREAS, the Board of Health desires to oppose any legislation related to public health issues that are not supported by evidence-based policy or best practices; and

WHEREAS, Colorado House Bill 24-1028 ("HB24-1028"), titled "Local Control of Life-saving Overdose Prevention Centers Act," currently being considered in the Colorado General Assembly 2024 legislative session, would amend Section 31-15-906, C.R.S. to allow the governing body of any municipality to authorize the operation of an overdose prevention center within its boundaries; and

WHEREAS, HB24-1028 provides no

role for local boards of health or public health agencies in the approval or oversight of overdose prevention centers, nor does it outline or require the development of specific criteria for the location and operation of such centers; and

WHEREAS, if passed, this legislation could lead to inconsistent public health practices between municipalities within the same community; and

WHEREAS, while proponents of overdose prevention centers claim that establishing such centers results in the prevention of drug overdoses, a greater opportunity to transition to treatment, and a reduction in crime, there is insufficient evidence to support any of these justifications; and

WHEREAS, the Board of Health objects to HB24-1028 because it is not supported by evidence-based policies or practices and does not provide a suitable framework for implementation.

NOW, THEREFORE, BE IT RESOLVED THAT THE EL PASO COUNTY BOARD OF HEALTH:

Hereby opposes the current draft of HB 24-1028 and urges state lawmakers to reject amendments to Section 31-15-906, C.R.S. that permit municipalities to establish overdose prevention centers.
