WHEREAS, pursuant to Section 25-1-508 C.R.S., the El Paso County Board of Health ("Board of Health") has the power and duty to accept, and through the public health director use, disburse and administer all federal aid, state aid, or other moneys allotted to an agency for county public health functions; and

WHEREAS, the Office of Management and Budget (OMB) released guidance 200.313 increasing the maximum allowable threshold for capitalizing equipment from \$5,000 to \$10,000 effective October 1, 2024; and

WHEREAS, the Board of Health has determined that capitalization of assets of Public Health should be decreased from \$25,000 to \$10,000 to align with the OMB guidance and the new El Paso County threshold.

NOW, THEREFORE, BE IT RESOLVED that the El Paso County Board of Health does hereby decrease the capitalization of assets threshold of Public Health from \$25,000 to \$10,000 to align with OMB guidance 200.313.


