- 2. Commissioner Gonzalez commented on the needle exchange program. Commissioner Gonzalez commented that the sites are acting outside of the law, and he contacted the Mayor of Colorado Springs and asked the law to be enforced.
- 3. General Briggs commented on the needle exchange program. General Briggs commented that the program is not a true "exchange" as multiple needles are being handed out at a time.
- 4. Councilmember Donelson commented on the needle exchange program. Councilmember Donelson commented that he has asked Colorado Springs City Council to look into the issue as he was not aware of these sites being active in Colorado Springs.
- 5. Dr. Chan commented on the needle exchange program. Dr. Chan commented that she was not aware that the program was allowing people to receive dozens of needles at a time.
- 6. Dr. Vu commented on the needle exchange program. Dr. Vu disagrees that this program is a harm reduction service. Dr. Vu inquired if there is data available to support or refute the efficacy of this program being a harm reduction service.
