

**Financial Services Department
2026 Sales & Use Tax Report
April 2026**

This report reflects Sales Tax revenue for consumer activity through April 2026, remitted to the Colorado Department of Revenue in collection period May 2026, and received by El Paso County in June 2026.

Use Tax Revenues are for activity in May 2026, and collection is in that same period.

The El Paso County Sales and Use Tax rate is 1.23%, consisting of a 1.0% General Fund Sales and Use Tax and a 0.23% Public Safety Sales Tax.

The **1.0% General Fund Sales and Use Taxes** are unrestricted funds used to support essential County services, including but not limited to, human services, health services, facilities, road maintenance, and park maintenance.

The **0.23% Public Safety Sales and Use Taxes** are used to directly fund urgent public safety needs to serve residents in El Paso County and are restricted for Law Enforcement, Emergency Response, and Criminal Justice needs.

Tax revenues for this reporting period are as follows:

- 1.0% Sales and Use Tax General Fund: **\$14,065,279**
- 0.23% Public Safety Sales and Use Tax (PST): **\$3,243,761**

For this reporting period:

- Combined Sales and Use Tax: up 0.79% when comparing April 2026 to April 2025, and up 3.68% year-to-date
- Sales Tax: up 3.84% when comparing April 2026 to April 2025, and up 5.07% year-to-date
- Use Tax: down 31.68% when comparing April 2026 to April 2025 and down 17.05% year-to-date

Sales Tax revenue by industry code. Key industry performance includes:

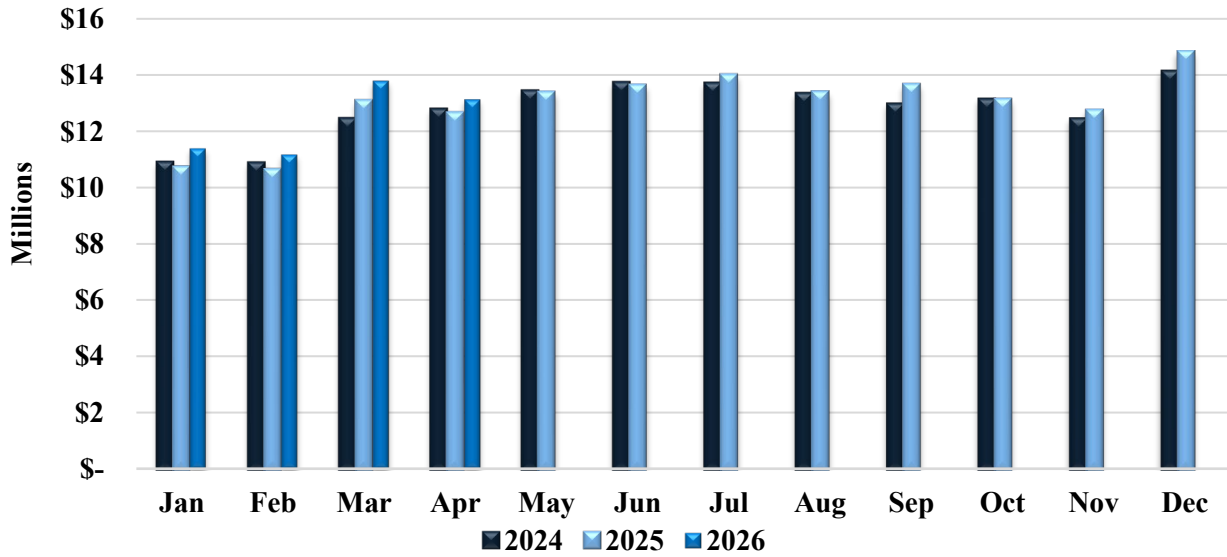
- Retail Trade: up 2.92% for April 2026 compared to April 2025
- Accommodations: up 12.19% for April 2026 compared to April 2025
- Wholesale Trade: up 6.65% for April 2026 compared to April 2025

Use Tax revenues are primarily driven by Building Materials and Motor Vehicle activity:

- Purchase of Construction and Building Materials collected by the Pikes Peak Regional Building Department: down 66.36% for April 2026 compared to April 2025 and down 40.22% year-to-date
- Purchase of Vehicles collected by Clerk and Recorder: down 1.13% in April 2026 compared to April 2025 and down 3.44% year-to-date

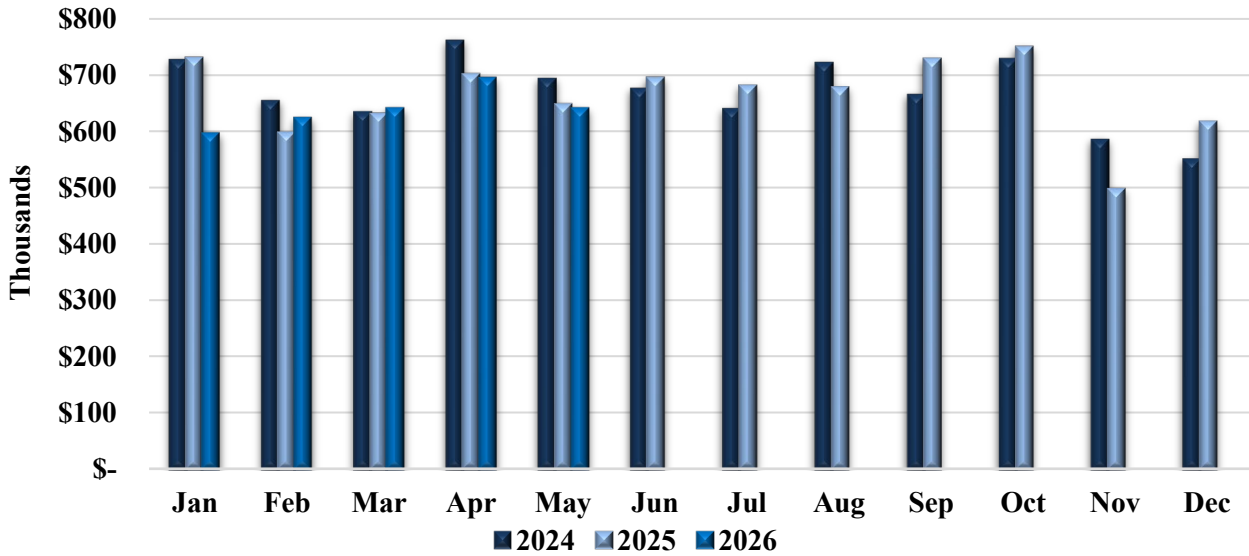

Historical Sales Tax on Retail Sales | April 2026 Collected by Colorado Department of Revenue



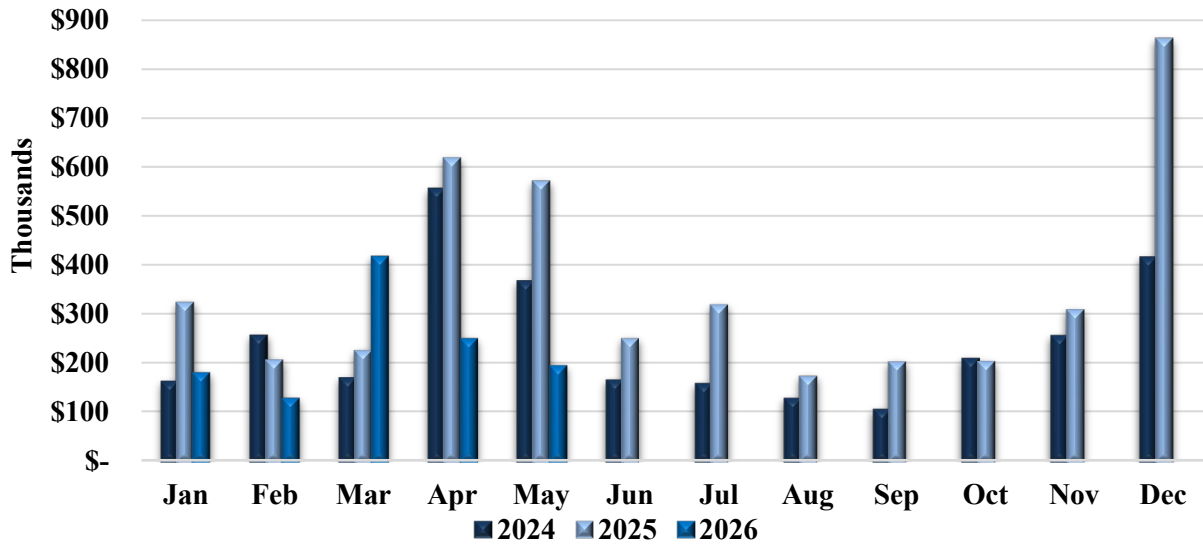

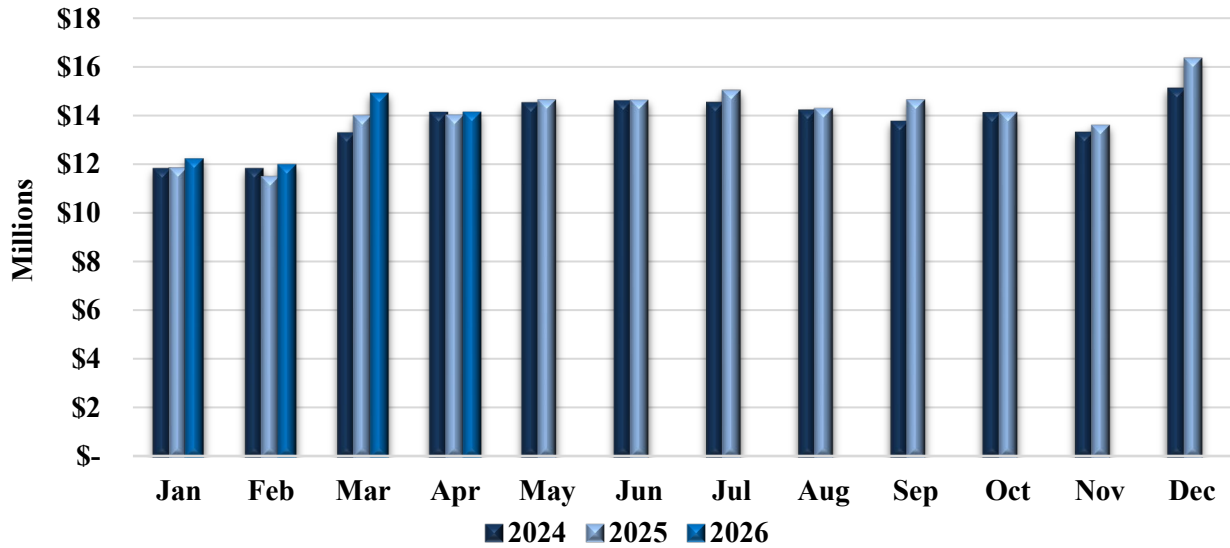
Historical Use Tax on Construction Materials | May 2026 Collected by Pikes Peak Regional Building Department and EPC

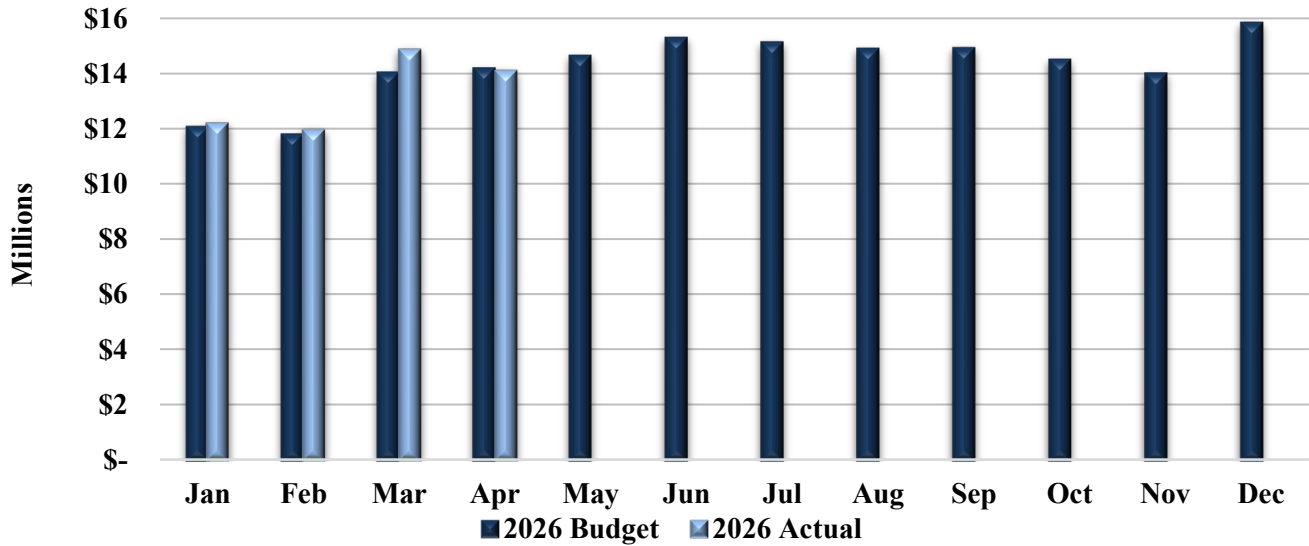

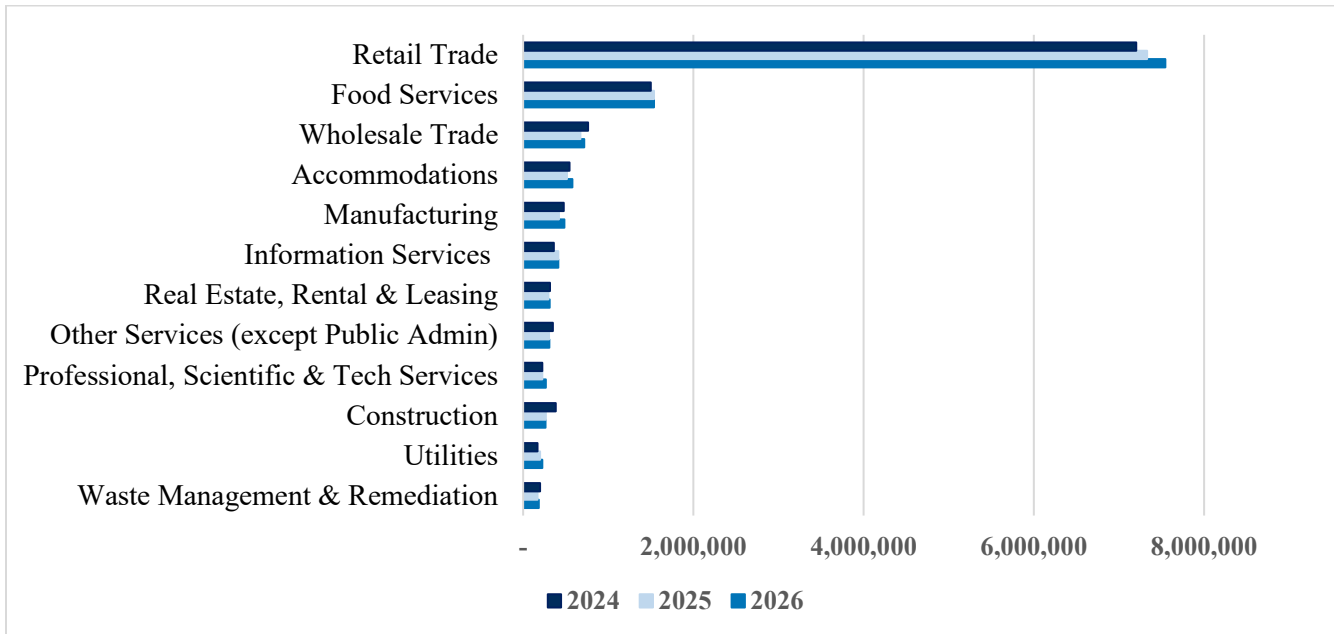

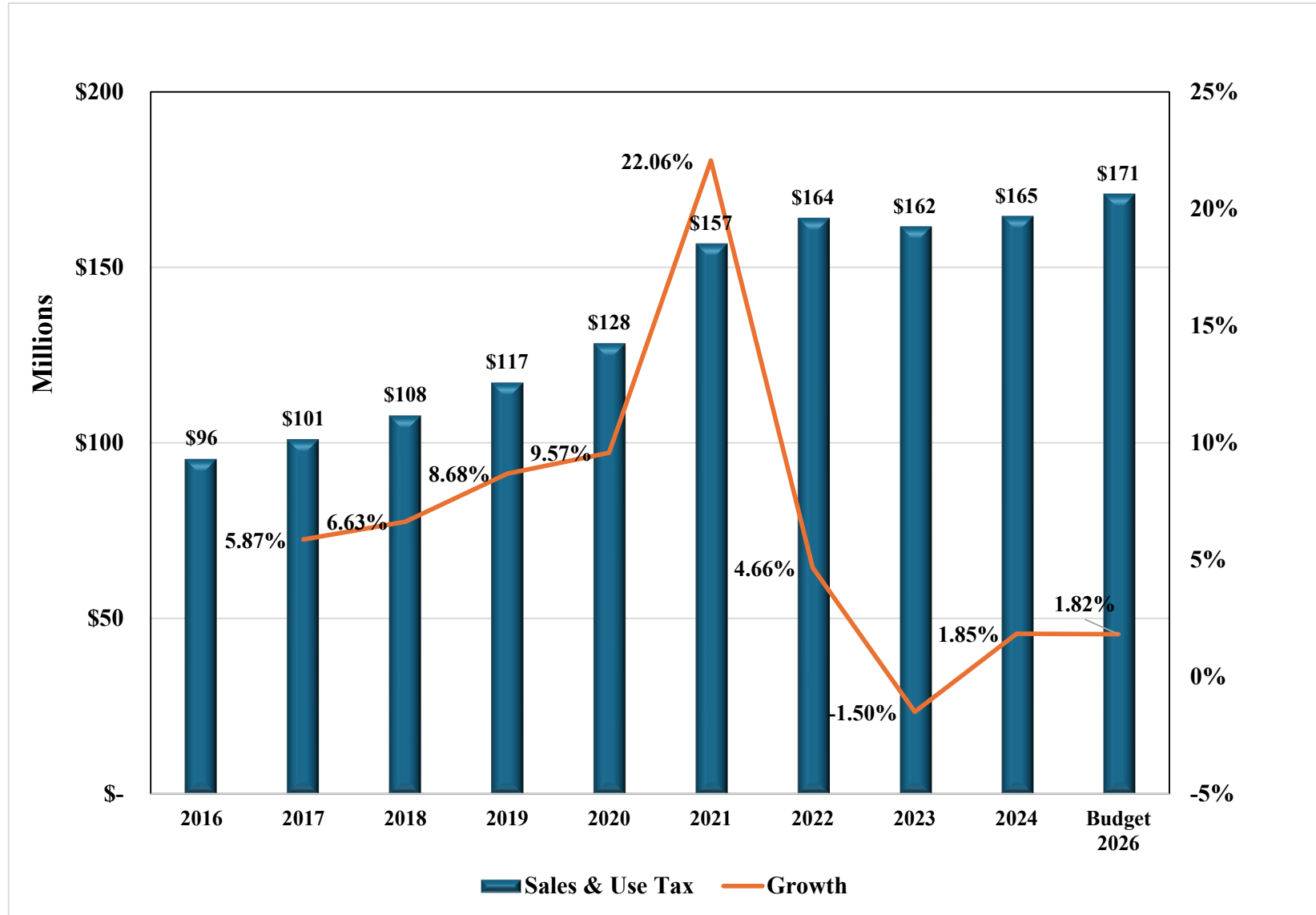

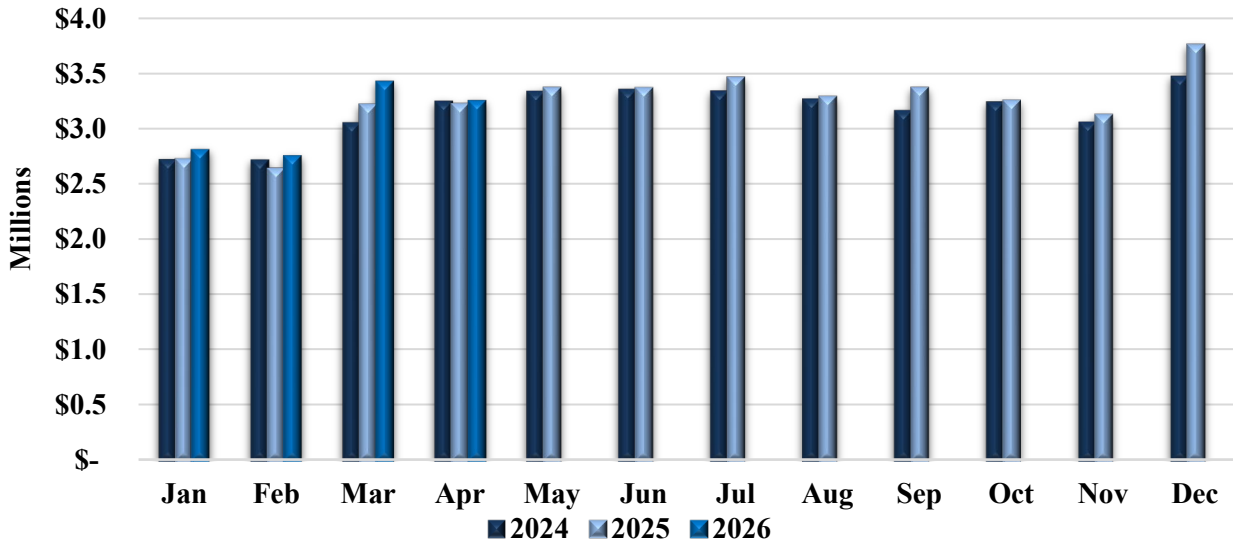

Historical Sales and Use Tax Collections by Year *All Components*

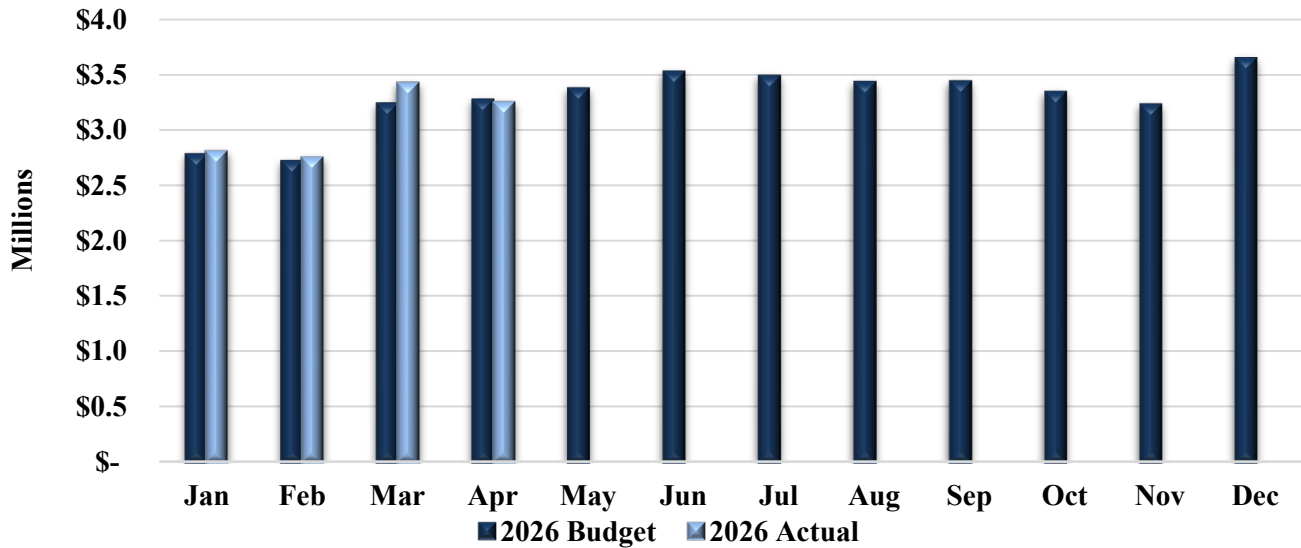
