

Sales & Use Tax (All Components) Public Safety's 0.23% August 2023

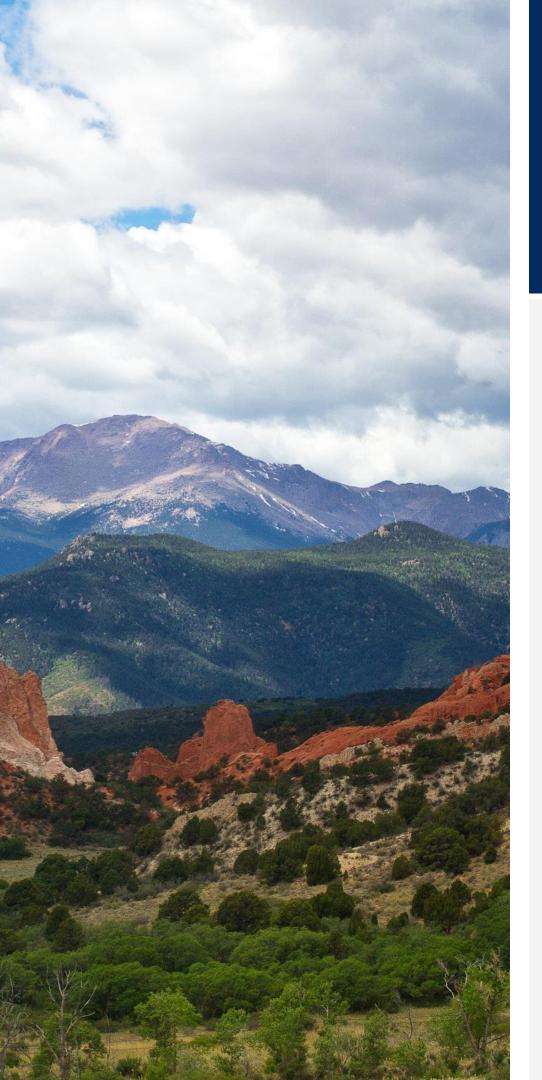
