# COMMISSIONERS

The Board of County Commissioners (BoCC) serves as both the administrative and policy-making body for El Paso County. Its authority comes directly from the Colorado General Assembly — meaning the County operates as a political subdivision of the state, not as an independent government. The Board only exercises powers specifically granted by law, along with those necessary to carry them out, as outlined in Article XIV, Section 6 of the Colorado Constitution

In 1976, El Paso County voters chose to expand representation by approving a five-member Board of Commissioners. Each commissioner is elected from one of five equally populated districts. These district boundaries are reviewed and updated by the Board every two years to ensure fair and equal representation.

The Board holds regular public hearings and meetings, all conducted in accordance with Colorado's open government laws — including the Colorado Sunshine Act of 1972 and the Colorado Open Records Act. To maintain high standards of integrity, the Board reviews and updates its Rules, Procedures, and Ethics Standards every year.

## **NET POSITION**

The statement of net position presents all of El Paso County's assets, deferred outflows of resources, liabilities, and deferred inflows of resources, with the difference reported as the net position. It is a snapshot of account balances as of December 31, 2024. Over time, the increases or decreases in the County's net position may serve as a useful indicator of whether the County's financial position is improving or deteriorating. Total net position has increased \$121.4 million (30.6%) from 2023 to 2024.


## **CHANGES IN NET POSITION**

The statement of activities presents information that indicates how the County's net position changed during the year reported, and shows total revenues earned and expenses incurred. When revenues exceed expenses, the County's net position increases. If expenses were to exceed revenues, net position would decrease.




# PROPERTY TAX DISTRIBUTION

In addition to collecting property taxes for the County, the El Paso County Treasurer's Office also collects property taxes on behalf of many other taxing authorities such as schools, cities, metro districts, water districts, fire districts and library district. After collection, the amounts due to other taxing authorities are distributed monthly to the appropriate parties. In 2024, \$883,947,171 was collected by the Treasurer's Office. Of that amount, less than 10% remained with the County after collection. See below for a breakdown of where your property taxes go.




## **GENERAL FUND REVENUES**

El Paso County took a proactive approach to its 2025 budget process, prioritizing economic sustainability and strategic investments while upholding our core principles of low taxes, providing high-quality public services, and building community trust through transparency. The County's robust, transparent, and collaborative multi-year budgeting approach effectively addresses critical needs and service demands—supporting resilience, recovery, and the consistent delivery of essential public services that foster community growth and success.


Included in the 2025 budget is a TABOR refund to taxpayers in the amount of \$8,252,409, to be carried out through a flat credit to residential property tax owners. In addition, the County, issued another temporary mill levy reduction of 1.159 to adjust for the TABOR cap in 2025. This reduction will impact the amount of property tax collected by the County for 2025, which is already the lowest of the ten largest Colorado counties.

In 2024, the County was over its TABOR cap by \$4,477,783. This amount was required to be reported as unearned revenue on the balance sheet. Next, the County's budget and financial forecast anticipate current and long-term future needs, focus on responsible development, and allow for continued additional expenditures for necessary infrastructure improvements, human capital investment, and increased investment in road infrastructure within these limitations.


For the 2025 budget, the County's primary focus was on critical infrastructure and road needs, investing in human capital, and addressing additional operational needs. The overall 2025 County expenditure budget is a total of \$533,025,318 which is a 8.43% increase over the ongoing 2024 budget. Throughout a transparent and collaborative process with all departments and offices, our 2025 budget addresses over \$33 million of our most critical needs, funded primarily through 2024 operational savings.
