I. Call to Order - The meeting was called to order at 9:30am by COG Chair Ruble Henderson.

- II. Administrative Items Ruble Henderson

- III. Introductions

  - b. Ryan Parsell welcomed new Board members and asked them to review the County's Volunteer Training video prior to the July 21 meeting. Paula will send the video to the new Board members.

## IV. Commissioner Liaison Comments - Holly Williams

- a. Public Safety Tax presentation is scheduled for July 8 Board of County Commissioners (BoCC) meeting.
- b. The Commissioners are distributing Citizen College 2025 cards at their Café Conversations events and various committee meetings.
- c. El Paso County GOP Vacancy Committee meets on June 17 to select a candidate to fill the District 5 seat on BoCC due to Commissioner Bremer's resignation.

## VI. Citizen College 2025 Update - Subcommittee

- a. For the benefit of the new COG Board members, Ruble explained the usual format for Citizen College 'report-outs' during the monthly COG Board meetings. At each Board meeting, Citizen College Session Managers will be asked if arrangements are ontrack with their specific Citizen College responsibilities, or if there are any risks/issues/significant events that the COG Board should be aware of. After this initial brief query among the Session Managers, Ruble will ask those who expressed risks/issues/significant event(s) for details so that the COG Board can decide course of action to resolve. Depending on the issues, some items may be deferred to the Citizen College Subcommittee to address. The goal of this reporting format is to use this portion of the Board meeting most efficiently to problem-solve, as needed.
- b. Ruble reviewed the mission of Citizen College: "To empower citizens to better understand what the County does for its residents, and to equip them with the tools to help strengthen our community."
- c. Citizen College schedule and Session Manager assignments (attached) were discussed.
- d. Group discussed the need to make the sessions as interactive as possible.
- e. Commissioner Williams offered the suggestion to include information about Citizen College on the 'Meeting is about to begin' page that appears online prior to BoCC meetings. Could also include information during BoCC meeting recess breaks. Commissioners will promote Citizen College during BoCC meetings.
- f. Promotional materials will encourage citizens to sign up for all sessions vs. individual sessions to gain a broader perspective on the various aspects of El Paso County government and the interconnectivity of the different functions.
