I. Administrative Items - Ruble Henderson

- b. Motion was made by Brenda Miller to accept the August 18 minutes. Ed Dills seconded. Motion passed.

II. Citizen College 2025 Updates

- a. 54 registrants to date
- b. Social media promotional videos featuring COG members Lanz Cook, Ed Dills, and Sarah Brittain Jack have been posted with 1,989 views to date. Videos featuring Jim Godfrey and Candi Boyer will be posted on Sept. 17 and 20 respectively. Nancy Nelsen in Communications will schedule video shoots with additional COG members over the next few weeks leading up to the start of Citizen College.
- c. Sessions Updates:
 - ➤ Citizen Service Center Session (Oct. 14) maximum COG member attendance is requested at this session to assist with logistics. Lanz is arranging donation of light refreshments from Springs Rescue Mission.

- Public Works/Emergency Preparedness Session (Oct. 15) Jim is working on details for 'Touch a Truck' portion of the session to give attendees an opportunity to see and learn about emergency and public works equipment and vehicles.
- ➤ District Attorney Session (Oct. 16) will be held at the D.A.'s Office. Centennial Hall is reserved as a back-up venue if the number of attendees exceeds capacity at the D.A.'s Office.
- ➤ Combined Courts Session (Oct. 17) Brenda will meet with Judge Sokol and her assistant on Sept. 22 to discuss plan for the session.
- ➤ Coroner's Office Session (Oct. 18) Sarah will verify capacity at the Coroner's Office to determine the maximum number of participants that can be accommodated for the session. She will also reach out to Dr. Russell-Kinsley to find out if her investigator is available to assist with the session, as he did last year.
- ➤ COG members should try to attend all sessions and should arrive at each site at least an hour prior to the start of the sessions to assist with setup.

d. Plan for final day of Citizen College

- b. County Ambassador Program training will be scheduled on rolling basis throughout the year. Externally, ambassadors represent El Paso County at events, building relationships with residents, stakeholders, and community groups.
