The following is hereby made a part of this solicitation:

SPECIFICATION CHANGES:

On Page 2 of General Specifications, Scope of Work, Section A. Project Description:

- Concrete Sidewalk Renovation Demolish and reconstruct approximately <u>840 SF</u> (was 500 SF) of concrete sidewalks between the pavilion and grandstands to achieve ADA accessibility standards (5% maximum grade).
- **3.** Concrete Sidewalks Install approximately <u>2,680 SF</u> (was 1,845 SF) of new 6" reinforced concrete sidewalks. One sidewalk will extend from the pavilions to Swink Arena. A second sidewalk will connect the new asphalt path to the existing playground. The third sidewalk will connect the new asphalt path to the existing sidewalk that leads to the Whitemore building.

REVISIONS TO BID FORM:

- Added 340 SF of concrete to remove on line #3.
- > Added 340 SF of new 6" concrete to line #9.
- > Added a line (#19) to capture the 15 LF of curb and fence work near the beer garden.

REVISIONS TO PLANS:

- > On sheet C-2 added two areas for concrete removal and replacement for a total of 340 SF.
- > On sheet D-2, detail 3 clarified the length of new curb and fence.
