- 1. DMV 1st floor restrooms:
 - a. What is to be done with the drinking fountain?
 Replace single drinking fountain with a High/Low setup. Contractor shall submit High/Low drinking fountain specs with their bid submission.
 - b. Where is the electrical access for the automatic door openers?

 Located in the ceiling or wall at nearby circuits that can handle required load.
 - c. Remove the following requirement from the Specification Document: Section II. 1. B. vi.
- 2. DMV 2nd Floor Men's Restroom:

Clarification - The light positioned above the bathroom partition will be relocated by the County. EPC Facilities will relocate lighting prior to construction start date.

- 3. Office of the Sheriff:
 - a. Can you confirm where the power for the automatic door opener will be ran from? Located in the ceiling or wall at nearby circuits that can handle required load.
 - b. How shall the tile be patched?Screw holes should be grouted, color to match existing.
- 4. Pro Building 1st Floor Women's Restroom:
 - a. Replace Specification Requirement: Section II. 3. A. iv. with "Reposition partition per ADA Specifications."
 - b. Replace Specification Requirement: Section II. 3. A. v. with "Add paper towel dispenser per ADA Specifications to by installed by EPC Facilities."
- 5. Pro Building 1st Floor Men's Restroom:
 - Replace Specification Requirement: Section II.3.B.iii. with "Add paper towel dispenser per ADA Specifications to by installed by EPC Facilities."
- 6. Pro Building 3rd Floor Men's Restroom: Add to Section II 3.C
 - a. Vi Fur out partition wall by two (2) inches to meet ADA Standards.
 - b. Vii Clarification: Door handles shall be removed by the County prior to work commencing.

- 11. Would we be able to start construction for all three location at the same time? YES. Contractor will ensure a work crew is present and working at each location to minimize disruptions of daily operations.
- 12. Do you have as-builts you can share of the existing restrooms? YES, as needed.
- 13. Is electrical engineering going to be required for added load, and will this be done by county before project start?
