**CLARIFICATIONS:**

Electronic bids shall be submitted no later than 3:00 PM (MST), Tuesday, March 15, 2022.

In the Project Special Provisions attached, Revisions of Section 202, Removal of Structures and Obstructions, **REPLACE** *"The cost of sawcutting shall be included in the price for item 202-Removal of Asphalt"* **WITH** *"The cost of sawcutting shall be included in the price for item 403-HMA Grade S or Grade SX (Patching)"*.

**ADMINISTRATION:**

Responses shall be submitted using the Updated Qualifications Statement attached with this addendum.  
Responses shall be submitted using the Revised Bid Form attached with this addendum.

**RESPONSE TO QUESTIONS:**

1. **Q:** Is it acceptable to use the form labeled "Qualification Statement", even though starting on page 2 on the top it's labeled Elbert Bridge Deck?  
**A:** Please use the attached Updated Qualifications Statement.
2. **Q:** Are there any permits required other than a ROW permit through EPC?  
**A:** The ROW permit through EPC is required.
3. **Q:** Section I.C states permit fees are waived, but Section II.F.4&12 states Contractor is responsible to pay all costs for permits. Just confirming permit fees are waived.  
**A:** Yes, ROW permit fee is waived.
4. **Q:** Is it acceptable to note in our "Work Plan & Schedule" portion of the proposal items an exception taken to the 50 working day performance period stated in the IFB and be honest with what we believe it will take us to successfully complete the work as proposed; without being considered "non-responsive" or "non-compliant" with the solicitation requirements? We're only concerned with the performance period assuming ALL line-item quantities may be accepted and awarded to be completed within this time frame.  
**A:** See revised bid form and replace 50 day working schedule with 60 day working schedule.
5. **Q:** Please clarify line items 201-Clearing & Grubbing, 203-Minor Grading, and 206-Excavation and Backfill for Structures.  
**A:** This work is to be considered for the new portion of sidewalk that needs to be widened. All other sidewalk items will be paid for in the sidewalk line item. Any newly disturbed areas outside of these limits will be the contractor's responsibility to revegetate.

**END OF ADDENDUM NUMBER TWO**

All other terms and conditions of the original IFB shall remain unchanged, and the subsequent bids received as a result of this solicitation shall be opened and evaluated in accordance with those terms and conditions.
