The original Offer must be received before the due date and time through electronic package through the Rocky Mountain E-Purchasing system. The Vendor is responsible for ensuring their proposal is posted by the due date and time outlined in the solicitation document.

If the submittal arrives late, it will not be included in the electronic lockbox.

### **RESPONSE TO QUESTIONS:**

- 1. Project special provisions/section 1. it states the installation of manhole rings or water valves will be paid for by the county at the contract price. There are no bid items for this. This work is not considered part of this work and the requirement verbiage is removed from this project.
- 2. Project special provisions/section 14. it states levelling course to be paid by unit measure. There is no pay item for this. This work is not considered part of this work and the requirement verbiage is removed from this project.

- Project special provisions/section 16. cement treated subgrade. It states to follow CDOT standard specification 308. There is no 308. This work is required for this project, see attached CDOT specification 308.
- 4. On the bridge deck milling what is the thickness? Bridge deck milling is 2".
- 5. On project 1 there is 11,600 tons of patching. this usually goes for \$180 per ton. This would be over 2 million dollars. On project 2 there is 8,150 tons. That would be about 1.5 million dollars. That is a lot of money. Is that a real quantity for patching? This line item has been adjusted and is now calculated as approximately 5% of the area for estimating purposes. See revised bid form.
- 6. What is the depth of the cement treated subgrade? For bidding purposes, use a depth of 12 inches.
- 7. What is the depth of the recycle in place? For bidding purposes, use a depth of 12 inches.
