CLARIFICATIONS:

It is the intention for all work quantities identified in the Bid Form and the roadways identified on the project map and location list to be completed; however, bidders shall be aware that funding is fixed for this project. The County reserves the right to delete or reduce any one or number of bid quantities or schedules by deleting project work as required. Unit Pricing shall be all and include all costs associated with each line item.

El Paso County will only accept electronic bid proposals submitted through the Rocky Mountain E-Purchasing system. A Submittal Log will be posted after the County has had an opportunity to review and verify the submittals offered to the County.

The original Offer must be received before the due date and time through electronic package through the Rocky Mountain E-Purchasing system. The Vendor is responsible for ensuring their proposal is posted by the due date and time outlined in the solicitation document.

If the submittal arrives late, it will not be included in the electronic lockbox.

RESPONSE TO VENDOR QUESTIONS

1. Q: there appears to be a problem with the MS Excel file titled "Subcontractor Monthly Payment Summary (CDOT Form #1413).xlsx". Looks like it might be corrupted and will not download properly.

A: Please see the attached (CDOT has the form on their website with a .xlsx filetype when it is a .pdf).

2. Q: Can the class 6 road base we use be comprised of recycled materials which still meet CDOT specifications?

A: Recycled concrete road base meeting CDOT specifications is acceptable.

3. Q: What is the asphalt removal width before replacing curb and gutter (1 foot or 2 feet)?

A: 2 feet.

4. Q: What are the requirements for the asphalt cut?

A: 6" or match existing, whichever is greater.

5. Q: What Pay Item in the Bid List refers to EPC Type A?

A: Item 20 is EPC type A (standard 6") and item 21 is EPC type A (modified 8")
