CLARIFICATIONS:

El Paso County will only accept electronic bid proposals submitted through the Rocky Mountain E-Purchasing system. A Submittal Log will be posted after the County has had an opportunity to review and verify the submittals offered to the County.

The original Offer must be received before the due date and time through electronic package through the Rocky Mountain E-Purchasing system. The Vendor is responsible for ensuring their proposal is posted by the due date and time outlined in the solicitation document.

If the submittal arrives late, it will not be included in the electronic lockbox.

ADMINISTRATION:

- Responses should follow the Response Format on pages 11-12 and include all responses to all mandatory requirements.
- We will be verifying submittals include the following:

If a submittal is missing any of the above-mentioned documentation the submittal may be returned to the vendor as non-responsive and be deemed ineligible to participate.

RESPONSE TO QUESTIONS:

1. Q: Do you know if the surveyor is responsible to set all monuments/easements on sheets 5.01 and 5.02 or will Farnsworth be doing that directly for the County? We didn't see it on the bid tab.
A: Farnsworth will set final monumentation for ROW and permanent easements after construction is complete. The Contractor shall stake ROW and easements for construction purposes.

2. Q: Due to the depth of this project and multiple tears of details, would the County consider extending the due date to the month of June?
A: No, the due date will not be extended.

3. Q: Will El Paso County allow ADS HP Storm per AASHTO M330 (corrugated dual wall polypropylene storm pipe) to be utilized for the storm sewer pipe as allowed per CDOT M standard as M-603-4 and specification section 712.13? HP Storm polypropylene pipe is approved for all storm pipe applications within CDOT jurisdiction.
A: No, this will not be allowed.

4. Q: In the interest of time can we omit the schedule prior to the bid date? With all the phasing and utility issues it will be very difficult to come up with a complete and accurate schedule along with this bid
A: No. The County understands that a detailed schedule is challenging but a schedule needs to be submitted. The schedule shall reflect the project elements that the contractor can control. Acknowledgements that utility relocations may affect the schedule are acceptable.
