1. I am a member of the Uniformed Services or Merchant Marine on active duty, or an eligible spouse or dependent of such a member, or a U.S. citizen temporarily residing outside the U.S., or Other U.S. citizen residing outside the U.S.;

2. Postmarks do not count as delivery of receipt. If you anticipate that this ballot will not reach the County Clerk's Office by the deadline, you can submit a request for an electronic ballot. You can access an electronic application form on the Colorado Secretary of State's website at www.govotecolorado.gov/mil.
