**2026 Guidelines**

**Purpose:** The Nature Camp Scholarship Program is designed to provide supplemental financial assistance to youth who are economically disadvantaged and demonstrate a genuine interest in attending nature camp.

**Scholarship Fund:** Scholarships are dependent on the current amount of donations in the Scholarship Fund and may not always be available. Scholarship amount will pay up to 50% of the camp fee. Qualified scholarships will be awarded in the order received.

**Eligibility:**

- Kindergarten - 8<sup>th</sup> Grade
- El Paso County residents
- Qualify for the Federal Free Lunch Program or the Reduced Free Lunch Program
- Income less than 130% of Federal Poverty Guidelines
- Limit of one scholarship per child per year

**Complete:**

- Scholarship Application form
- “Why I Want to Attend Nature Camp” Essay
  - The essay must be at least 1 paragraph, but no more than 2 pages in length.
  - The essay must be written by the child. If the child is unable to write the essay, the adult may write it for them in the child’s words.

**Scholarship Application Deadline:**

- **A minimum of 2 weeks before the requested camp session (Camps may fill quickly on a first-come, first-served basis. We recommend applying soon.)**

**Notification:** You will be notified if the application is approved or not.
